The NIH exhibit will be juried with 23 paintings that are suitable for a hospital environment chosen to be displayed from March 12th through May 6th, 2011.

Eligibility:

Current members in good standing with the Laurel Art Guild may apply and submit up to four (4) images.

Please only apply if you can drop off and pick up on the required dates as it will be the artist's responsibility to carry artwork to and from MAC.

Entry/Delivery Requirements:

Screening will be done by Richard Zandler prior to the NIH curator's final approval.

Screening will be done by jpg files on CDR or CD-RW. Digital images on CD must be at 300 dpi in jpg format and no larger than 5x7". Files and CD-RW should be labeled:

A-Last name-First name-Title of work.

B-C-D same as A.

Deadline to submit entry package (entry form, CD-R or RW, \$5.00 entry fee) will be Friday, January 7, 2011.

Notification will be made by: Friday, February 11, 2011 by email/mail. No phone calls.

1st, 2nd, 3rd, HM will be awarded.

Delivery and pick up:

MAC Drop-off: Friday March 4, 2011--- Time: 11 – Noon or 6 – 7:00 p.m..

MAC Pick-up: Monday, May 9, 2011--- Time: 7 p.m., prior to our monthly guild meeting

Conditions:

All artwork must be matted and framed suitable for use with the galleries' security locks. The locks fit 'Nielson' style metal framing that has 1/2" grooves in the back. On wooden frames, two tiny holes will be drilled to attach the lock onto the back of the frame. All framing must be to museum standards.
